The following wage rates, fringe benefits, and report procedures apply for Construction Wiremen (CWs) working under the Addendum to the Local Union 103, IBEW\Boston Chapter, NECA Inside Construction and Telecommunications and Integrated Building Systems Agreements.

Working Assessment deduction for Construction Wiremen, Telecom, Level 2 2% of gross labor payroll
Working Assessment deduction for Construction Wiremen, Level 1 2% of gross labor payroll
- 4) Construction Wiremen are exempt from the Holiday/Vacation Deduction.
- 5) JATC contributions are based on current rates for Inside Journeymen Wiremen and Technicians.
- 6) EILMCT contributions are based on current rates for Inside Journeymen Wiremen and Technicians.
Construction Wiremen, Level 1 are exempt from EILMCT contributions.
- 7) NEBF - National Electrical Benefit Fund contributions are 3% of gross payroll.
- 8) NECA\SC - NECA Service Charges are 0.6% of productive labor payroll and are not included in Total.
- 9) Construction Wiremen, Level 1 are exempt from Health Benefit contributions.
- 10) Construction Wiremen are exempt from the Local Pension, and Deferred Income Fund Contributions.
