SHIFT RATE MEMORANDUM

TO: All Signatories, Principal Agreement (Boston & Vicinity)
FROM: Local Union 103, IBEW and Boston Chapter, NECA
SUBJECT: SHIFT WORK Wage Rates, Fringe Benefits and Report Procedures
DATE: September 1, 2026

The appropriate journeyman rates for work performed under the SHIFT WORK CLAUSE
 are as follows: Effective: **1-SEP-2026 thru 28-FEB-2027**

1st SHIFT

1st Shift Hourly Rate: \$68.78 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$68.78) = \$550.24 per shift
 1st Shift Overtime Rate: \$550.24 / 8 hours worked x 1½ = \$103.17 per hour

2nd SHIFT

2nd Shift Hourly Rate: \$68.78 + 17.3% = \$80.68 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$80.68) = \$645.44 per shift
 2nd Shift Overtime Rate: \$645.44 / 8 hrs. worked x 1½ = \$121.02 per hour

3rd SHIFT

3rd Shift Hourly Rate: \$68.78 + 31.4% = \$90.38 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$90.38) = \$723.04 per shift
 3rd Shift Overtime Rate: \$723.04 / 8 hours worked x 1½ = \$135.57 per hour

NOTES: For work performed under the shift clause:

SHIFT RATES for General Foreman, Foreman, and Apprentices are based on the Journeyman Shift
 respective regular hourly rate plus the shift differential:

e.g. 2nd Shift Foreman Rate = \$75.66 + 17.3% = \$88.75 per hour

PAY FOR SHIFT equals applicable shift hourly rate times 8 hours.

PAY FOR PARTIAL SHIFTS equals applicable shift hourly rate times ACTUAL HOURS

WORKED e.g. 5 hours for 2nd Shift Foreman = \$88.75 x 5 hrs. = \$443.75

OVERTIME RATES are based on the Shift hourly rate times 1½

On Shift Work between 8:00 a.m. Saturday and 8:00 a.m. Monday, the regular overtime rates
 in the Agreement shall apply. The overtime rate for any shift shall not exceed 2 times the
 regular hourly rate of pay; e.g. Journeyman maximum rate = \$68.78 x 2 = \$137.56

TOTAL CLOCK HOURS, as entered on the Monthly Report Form, should equal actual hours *paid*.

FRINGE BENEFITS on shift work are contributed on the actual hours *paid* (8 hours per shift)
 without regard to premium rates.
