SHIFT RATE MEMORANDUM

TO: All Signatories, Telecommunications Agreement (Boston & Vicinity)
FROM: Local Union 103, IBEW and Boston Chapter, NECA
SUBJECT: SHIFT WORK Wage Rates, Fringe Benefits and Report Procedures
DATE: SEPTEMBER 1, 2022

The appropriate Technician rates for work performed under the SHIFT WORK CLAUSE are as follows: Effective: **1-SEP 2022 thru 28-FEB-2023**

1st SHIFT

1st Shift Hourly Rate: \$46.04 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$46.04) = \$368.33 per shift
 1st Shift Overtime Rate: \$368.33 / 8 hours worked x 1½ = \$69.06 per hour

2nd SHIFT

2nd Shift Hourly Rate: \$46.04 + 17.3% = \$54.01 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$54.01) = \$432.08 per shift
 2nd Shift Overtime Rate: \$432.08 / 8 hrs. worked x 1½ = \$81.02 per hour

3rd SHIFT

3rd Shift Hourly Rate: \$46.04 + 31.4% = \$60.50 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$60.50) = \$484.00 per shift
 3rd Shift Overtime Rate: \$484.00 / 8 hours worked x 1½ = \$90.75 per hour

NOTES: For work performed under the shift clause:

SHIFT RATES for General Foremen, Foremen, Sub-foremen and Apprentices are based on the respective regular hourly rate plus the shift differential:

e.g. 2nd Shift Foreman Rate = \$50.65 + 17.3% = \$59.41 per hour

PAY FOR SHIFT equals applicable shift hourly rate times 8 hours.

PAY FOR PARTIAL SHIFTS equals applicable shift hourly rate times ACTUAL HOURS

WORKED e.g. 5 hours for 2nd Shift Foreman = \$59.41 x 5 hrs. = \$297.05

OVERTIME RATES are based on the Shift hourly rate times 1½

On Shift Work between 8:00 a.m. Saturday and 8:00 a.m. Monday, the regular overtime rates in the Agreement shall apply. The overtime rate 0

regular hourly rate of pay; e.g. Technician maximum rate = \$46.04 x 2 = \$92.08

TOTAL CLOCK HOURS, as entered on the Monthly Report Form, should equal actual hours *paid*.

FRINGE BENEFITS on shift work are contributed on the actual hours *paid* (8 hours per shift)

without regard to premium rates.
