SHIFT RATE MEMORANDUM

TO: All Signatories, Principal Agreement (Boston & Vicinity)
FROM: Local Union 103, IBEW and Boston Chapter, NECA
SUBJECT: SHIFT WORK Wage Rates, Fringe Benefits and Report Procedures
DATE: March 1, 2024

The appropriate journeyman rates for work performed under the SHIFT WORK CLAUSE are as follows: Effective: **1-MAR-2024 thru 31-AUG-2024**

1st SHIFT

1st Shift Hourly Rate: \$61.86 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$61.86) = \$494.88 per shift
 1st Shift Overtime Rate: \$494.88 / 8 hours worked x 1½ = \$92.79 per hour

2nd SHIFT

2nd Shift Hourly Rate: \$61.86 + 17.3% = \$72.56 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$72.56) = \$580.48 per shift
 2nd Shift Overtime Rate: \$580.48 / 8 hrs. worked x 1½ = \$108.84 per hour

3rd SHIFT

3rd Shift Hourly Rate: \$61.86 + 31.4% = \$81.28 per hour
 Pay for Shift: 8 hours x shift rate (8 x \$81.28) = \$650.24 per shift
 3rd Shift Overtime Rate: \$650.24 / 8 hours worked x 1½ = \$121.92 per hour

NOTES: For work performed under the shift clause:

SHIFT RATES for General Foreman, Foreman, and Apprentices are based on the Journeyman Shift respective regular hourly rate plus the shift differential:

e.g. 2nd Shift Foreman Rate = \$68.05 + 17.3% = \$79.82 per hour

PAY FOR SHIFT equals applicable shift hourly rate times 8 hours.

PAY FOR PARTIAL SHIFTS equals applicable shift hourly rate times ACTUAL HOURS

WORKED e.g. 5 hours for 2nd Shift Foreman = \$79.82 x 5 hrs. = \$399.10

OVERTIME RATES are based on the Shift hourly rate times 1½

On Shift Work between 8:00 a.m. Saturday and 8:00 a.m. Monday, the regular overtime rates in the Agreement shall apply. The overtime rate for any shift shall not exceed 2 times the regular hourly rate of pay; e.g. Journeyman maximum rate = \$61.86 x 2 = \$123.72

TOTAL CLOCK HOURS, as entered on the Monthly Report Form, should equal actual hours *paid*.

FRINGE BENEFITS on shift work are contributed on the actual hours *paid* (8 hours per shift) without regard to premium rates.
